Limited ("MCH") pursuant to the share lending agreement entered into between the Stabilising Manager and MCH. For the purposes of Section 4 of the Securities and Futures Act, Chapter 289 of Singapore, MCH was deemed to be interested in such shares. The Stabilising Manager has now returned the 1,808,900 borrowed shares to MCH, and MCH has ceased to be deemed to be interested in the 1,808,900 shares, but will instead be directly interested in the said 1,808,900 shares."
