ACQUISITION OF 4 PRESCHOOL CENTRES IN SYDNEY, AUSTRALIA

DBS Bank Ltd. was the sole issue manager, bookrunner and underwriter (the "**Sole Issue Manager, Bookrunner and Underwriter**") for the initial public offering of shares in, and listing of, the Company on the Mainboard of the SGX-ST in November 2017. The Sole Issue Manager, Bookrunner and Underwriter assumes no responsibility for the contents of this announcement.

The Board of Directors of MindChamps PreSchool Limited (the "**Company**") is pleased to announce that:

- a. the Company's indirect wholly-owned subsidiary, MindChamps Early Learning & Care @ Cherrybrook Pty. Limited, has entered into a Business Sale and Purchase Agreement with Ropes Crossing Pty Ltd as trustee for Ropes Crossing Unit Trust, Pham Business Investments Pty Ltd as trustee for the Pham Business Investment Trust, Ms Thi Nho Pham, Learning Services Pty Ltd and CBS Leasing Pty Ltd to acquire the business and assets of a preschool centre at Ropes Crossing, Sydney, Australia, at a purchase consideration of A\$3,653,000;
- b. the Company's indirect wholly-owned subsidiary, MindChamps Early Learning & Care @ Cherrybrook Pty. Limited, has entered into a Business Sale and Purchase Agreement with CBS West Hoxton Pty Ltd as trustee for the CBS West Hoxton Unit Trust, Pham Business Investments Pty Ltd as trustee for the Pham Business Investment Trust, Ms Thi Nho Pham, Learning Services Pty Ltd and CBS Leasing Pty Ltd to acquire the business and assets of a preschool centre at West Hoxton, Sydney, Australia, at a purchase consideration of A\$1,852,500;
- c. the Company's indirect wholly-owned subsidiary, MindChamps Early Learning & Care @ Cherrybrook Pty. Limited, has entered into a Business Sale and Purchase Agreement with CBS Group Investments Pty Ltd as trustee for the CBS Group Trust, Pham Business Investments Pty Ltd as trustee for the Pham Business Investment Trust, Ms Thi Nho Pham, Learning Services Pty Ltd and CBS Leasing Pty Ltd to acquire the business and assets of a preschool centre at Lane Cove, Sydney, Australia, at a purchase consideration of A\$4,147,000; and
- d. the Company's wholly-owned subsidiary, MindChamps Australia Pty Ltd, has entered into a Business Sale and Purchase Agreement with CBS Group Investments Pty Ltd as trustee for the CBS Group Trust, Pham Business Investments Pty Ltd as trustee for the Pham Business Investment Trust, Ms Thi Nho Pham, Learning Services Pty Ltd and CBS Leasing Pty Ltd to acquire the business and assets of a preschool centre at Penrith, Sydney, Australia, at a purchase consideration of A\$3,282,500.

The assets to be acquired under each of the 4 Business Sale and Purchase Agreements referred to above include, among others, the authorisations of the Australian government agency to carry on

providing child care and education services at each respective preschool centre, the benefit of the leases of each respective preschool centre premise, the intellectual property rights and licences in relation to each respective business, and the plant and equipment of each respective preschool centre.

Each of the respective purchase considerations referred to above was arrived at on an arms' length, willing-seller-willing-buyer basis, after taking into account various factors such as the existing assets, goodwill, financial position and business prospects of each of the respective preschool centres, and is intended to be satisfied from a combination of cash from the Company's IPO proceeds and an acquisition loan, and is to be paid upon completion of each respective Business Sale and Purchase Agreement, subject to satisfaction of conditions precedent.

The above acquisitions are in the ordinary course of the expansion of the Company's business for the purposes of Chapter 10 of the Singapore Exchange Securities Trading Limited Listing Manual. The said acquisitions are expected to have a positive impact on the earnings per share of the Group for the financial year ending 31 December 2018.

None of the Directors or substantial shareholders of the Company have any interest, directly or indirectly, in the said transactions save for their interest arising by way of their shareholdings and/or directorships, as the case may be, in the above transactions.
