While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

In addition, David Chiem Phu An is deemed to be interested in the Shares in which his spouse, Catherine Du, has an interest, including the 1,710,528 Shares which she holds through DBS Nominees (Private) Limited. As David Chiem Phu An already has a deemed interest in the Shares held by MCH, such interest has not been additionally accounted for as his deemed interest in Shares in which his spouse, Catherine Du, has an interest.
