In appointing the Chairman of the Meeting (or any person other than the Chairman of the EGM) as proxy, a shareholder (whether individual or corporate) must give specific instructions as to voting, or abstentions from voting, in the form of proxy, failing which the appointment of the Chairman of the Meeting (or any person other than the Chairman of the EGM) as proxy for that resolution will be treated as invalid. A proxy need not be a member of the Company.

- 1. Please insert the total number of Shares held by you. If you have Shares entered against your name in the Depository Register (maintained by The Central Depository (Pte) Limited), you should insert that number of Shares. - 2. Shareholders (except a Relevant Intermediary as defined herein) may exercise their voting rights at the EGM in person. As an alternative to voting in person at the EGM, shareholders are entitled to appoint not more than two (2) proxies, or failing him/her, the Chairman of the EGM as their proxy to do so on their behalf. Where such member's Proxy Form appoints more than one (1) proxy, the proportion of the shareholding concerned to be represented by each proxy shall be specified in the Proxy Form, otherwise the Company shall be entitled to treat the first named proxy as representing the entire number of Shares registered against the member's name in the Depository Register and any second named proxy as an alternate to the first named proxy. - 3. A shareholder who is a relevant intermediary is entitled to appoint more than two (2) proxies, but each proxy must be appointed to exercise the rights attached to a different share or shares held by such shareholder. Where such shareholder's Proxy Form appoints more than two (2) proxies, the number and class of shares in relation to which each proxy has been appointed shall be specified in the Proxy Form or alternatively, separate Proxy Forms should be used.
- 4. CPF or SRS Investors may attend and cast his/her vote(s) at the EGM. CPF or SRS Investors who are unable to attend the EGM may appoint the Chairman of the EGM as proxy, and should approach their respective CPF Agent Banks or SRS Operators (being relevant intermediaries) at least seven (7) working days before the EGM (i.e. by 5.00 p.m. on Monday, 4 November 2024), to ensure that their votes are submitted.
- 5. A "Relevant Intermediary" is
 - (a) a banking corporation licensed under the Banking Act 1970 of Singapore or a wholly owned subsidiary of such a banking corporation, whose business includes the provision of nominee services and who holds shares in that capacity; or
 - (b) a person holding a capital markets services licence to provide custodial services for securities under the Securities and Futures Act 2001 of Singapore and who holds shares in that capacity; or
 - (c) the Central Provident Fund Board established by the Central Provident Fund Act 1953 of Singapore, in respect of shares purchased under the subsidiary legislation made under that Central Provident Fund Act 1953 providing for the making of investments from the contributions and interest standing to the credit of members of the Central Provident Fund, if the Board holds those shares in the capacity of an intermediary pursuant to or in accordance with that subsidiary legislation.
- 6. A proxy need not be a member of the Company.
- 7. The instrument appointing the Chairman of the EGM (or any person other than the Chairman of the EGM) as proxy must be deposited (a) at the registered office of the Company at 6 Raffles Boulevard #04-100 Marina Square Singapore 039594; or (b) be submitted via email to ir@mindchamps.org; not less than seventy-two (72) hours (i.e. by 10.00 a.m. on Monday, 11 November 2024), before the time appointed for holding the EGM.
- 8. The instrument appointing the Chairman of the EGM (or any person other than the Chairman of the EGM) as proxy must be under the hand of the appointor or of his/her attorney duly authorised in writing. Where the instrument appointing the Chairman of the EGM (or any person other than the Chairman of the EGM) as proxy is executed by a corporation, it must be executed either under its seal or under the hand of an officer or attorney duly authorised. Where the instrument appointing the Chairman of the EGM (or any person other than the Chairman of the EGM) as proxy is executed by an attorney on behalf of the appointor, the letter or power of attorney or a duly certified copy thereof must be lodged with the instrument. The dispensation of the use of common seal pursuant to Sections 41A, 41B and 41C of the Companies Act 1967 is applicable at this EGM.
- 9. The Company shall be entitled to reject the instrument appointing the Chairman of the EGM (or any person other than the Chairman of the EGM) as proxy if it is incomplete, improperly completed or illegible or where the true intentions of the appointor are not ascertainable from the instructions of the appointor specified in the instrument appointing a proxy or proxies.
- 10. In the case of shareholders of the Company whose shares are entered against their names in the Depository Register, the Company may reject any instrument appointing the Chairman of the EGM (or any person other than the Chairman of the EGM) as proxy lodged if such shareholders are not shown to have shares entered against their names in the Depository Register seventy-two (72) hours before the time appointed for holding the EGM as certified by The Central Depository (Pte) Limited to the Company.
